The online application for dual enrollment admission for the Fall semester is now open! I am enclosing the necessary information you will need to help you apply and register for the Fall term. A representative from Jefferson State will be available during our high school registration dates to answer any additional questions that you may have.

Included you will find a checklist. The checklist should be reviewed to ensure that you meet all of the requirements for the class you plan to enroll.

Tuition will be \$444.00 for a three credit hour course. These costs are subject to change without notice at any time upon requirements set forth by the State Board of Education. The deadline for payment of full tuition and fees is July 28, 2016. The student will be dropped from the course and their seat will become available to another student. After this date there is no guarantee that the student will be able to enroll in the desired class.

Dual Enrollment Students and Parents:

Jefferson State Community College classes begin August 19, 2016. The registration process for our students will require the completion of the online application, a signature page, and a copy of the student's driver's license. Several of our students have already completed this information and will be registered for the fall term. Please make sure your student completes the registration process in order to attend Jefferson State. If your student is planning to take English 101, the student must have an 18 on the English portion of the ACT or complete the COMPASS placement test at Jeff State before July 18, 2016! Please review Jeff State's policy on continuous eligibility in their Dual Enrollment program:

Students who meet the criteria for initial admission to a Dual Enrollment for Dual Credit Program as specified in the ACCS Procedure for Dual Enrollment for Dual Credit for High School Students, Section 2, will remain in continuous eligibility as long as a grade of "C" or better in all attempted college courses is earned. Students who fail to meet this minimum grade requirement or who withdraw from a course will be suspended from the program for a minimum of one term. The one term suspension may not be served during the Summer term. The student may not re-enroll until the suspension has been served. For re-entry, the student must reapply to the program and must meet the minimum (unweighted) grade point average of 2.5 on a 4.0 scale.

The application and signature page must be completed and turned in to Pell City High School by June 30, 2016. If you have questions about the paperwork please contact Jennifer Moses at 205.338.2250 ext 229 or jennifer.moses@pellcityschoools.net. The fall semester begins August 19, 2016.
